RECTOR'S REPORT

Rector's Report

It has been a miraculous, faith, life and love affirming year! 2024 saw the completion of the Woodstock Pantry build and Grand Opening. Thanks to the generosity and labor of this parish, the wider community, Woodstock Pantry volunteers, the diocese and other churches, local businesses and non-profits, this \$300,000 project was fully funded by the end of the year. Since the Woodstock Pantry started in 2020, this parish has shown tremendous vision, dedication and willingness to say yes to the Spirit at each pivotal turn. We have witnessed miracles in the way God has provided as we respond to a sense of call. We continue to witness miracles in the lives of people touched by the Outreach ministries.

In addition to the Pantry build, we were able to add the accessible entrance on the west side of the church, paid for by the generous bequest from Bill Stewart. It enlivens that part of our campus and helps us be more welcoming through dignified, easy access into the building.

We welcomed a number of new members over the last year and added the Newcomers Dinners to help people get to know each other better. The Faith Conversations formation offering in the fall, led by Alan Murray, Deacon Maureen Hagen and I were well-attended and engaging.

Our Children's Ministry successfully relaunched the Godly Play program, which saw an increase Sunday morning participation. The Parents Night Outs continue to grow.

The fairly new Digital Ministry continues to grow and is now being included in the National Parochial Report. On average we have 12 people on Sunday mornings worshipping on Facebook Live with 8 more doing so after. That's 20 additional worshippers that we don't see in the pews, but who join us in prayer every week.

We had a wonderful Bishop's Visitation with 3 receptions 2 confirmations and 1 reaffirmation of faith, and also 2 baptisms during the year.

The Advent/ Christmas Season was as beautiful as ever. The new parishioner-made costumes were a hit. The added Christmas live animal pageant at 4pm on Christmas Eve was enthusiastically received. We had 155 at the 4pm service and over 100 at the late service.

As you will see in the pages that follow, both new and longstanding ministries are thriving and finding ways to express Christian faith through love in the ways they serve.

May the blessings we have experienced in this last year give us courage and confidence as we say yes to the next thing God is calling us to!

Here are a few reminders to make your donations even more worthwhile:

- **DO** distinguish between items you're giving to the Mustard Seed Thrift Shop, and outreach items for the Clothing Closet; this saves our volunteers time and assures your intentions are honored. Well-marked donation boxes are just off the narthex, opposite the bathroom.
- **DO** give clean clothing items in good repair (mark "clean" or "washed" if you can; unmarked items may require re-washing and drying, which increases our utility costs).
- **DO** bring items suitable for folks living outside, as well as for our housed neighbors; aim for items you would be happy to offer if you donated them face-to-face.
- **DO** donate seasonally appropriate items (coats, raingear, jackets, hoodies for rain and cold; T-shirts and shorts during summer; jeans most of the time)
- **DO** give new socks in packaging only. For hygiene reasons, no used socks, underwear, lingerie, or sleepwear will be accepted.
- Please, consider saying a prayer for the people who'll be the recipients of your generosity.

We also hired a new Outreach Coordinator, Leslie Rangel, who is doing incredible work and is helping us refine (and expand) our outreach programs.

JUNIOR WARDEN'S REPORT

The completion of the pantry required organizing some painting crews for priming, interior and exterior painting, landscaping which is still in process, a manual for start up of the boiler each fall, continuing inspections, and updating the Jr Warden's notebook with pictures and easy "how to's" on routine tasks.

Repaired broken water pipe (probably due to the freeze) and removed the garden water pumps due to code issues and cost to correct.

Heating repairs completed January 2025 due to aging equipment.

Black chairs' upholstery repaired by Hot Meals volunteers.

In process of replacing batteries in door sensors and motion detectors as they are expiring.

Inspections, cleaning or testing completed as required on the following:

- Range Hood Fire Suppression
- Fire Extinguisher
- Wet Sprinkler System
- Backflow removed
- Fire Monitoring System
- Grease Trap Cleaning

Spring and fall clean ups were held with great participation.

Thank you to my "posse" of helpers for large and small tasks-Rob Bekurs, Jon Pitner, Katharine Gartner, Chuck Martin, Johnny Foley, Giacomo, Laurie & Steve McDowell, Judy Clark and all the folks who turned out for the spring and fall clean ups, it would be impossible without you. Future needs:

- Replacing round fluorescent light fixtures 22 of them urgent will go dark one by one.
- Discerning the leak issue with Nave roof windows and repair, steep roof adds to costs.
- Repair/replace attic fan over the parish hall to promote better summer cooling.
- Install business hour accordion gates by the pantry and NE Nave door to prevent camping and fire building adjacent to our buildings.
- Exterior of pantry, the white section, needs to be painted again during summer weather with good quality paint.
- Replacing flood light fixtures for steeple-steep roofs add to cost.
- Replace dated sprinkler heads for fire suppression at next inspection (\$800-\$1000).

FINANCE

FINANCE COMMITTEE

Respectfully submitted by Maryruth Storer

The Finance Committee meets 7-9 times each year to review the current financials of All Saints, recommend funding sources for special projects or purchases, and to develop the draft budget for Vestry approval. We track income and expenses to ensure we stay as close to our budget as possible. We oversee the annual Stewardship Campaign and fundraising events.

In 2022, 2023 and 2024, we began the year with a slight deficit in the approved budget, and in each year we ended with a slight surplus. This has given us confidence to take the same path in 2025. We need to remember that this 2025 budget does not include funding for an office administrator or a youth minister, and that a few specific expenses normally part of our budget are being covered by a designated donation from a generous parishioner (in addition to their pledge.)

The Stewardship Campaign for 2025 resulted in pledges for \$247,374 from 100 pledging units we had 95 pledging units in 2024). Of these, 11 were from people who had not pledged for 2024. Pledges can be made at any time during the year if you missed submitting one during the Stewardship Campaign.

Maryruth Storer has been appointed Finance Committee Chair by the Vestry. Current Committee members include Treasurer Jerry Meter, Larry Chalew-Fuller, Senior Warden Lindsay Strannigan, and Rector Andria Skornik. Nancy Carr continues writing thank you notes for donations, which is much appreciated.

THE MUSIC PROGRAM

2024 saw All Saints' Music Program fully back to its former strength in both personnel and choral repertoire.

Choir membership is holding at 20. Our new season started Sunday, September 8, and continues as a regular feature of Sunday worship. Thursday evening and Sunday morning rehearsals continue in the chancel. Regular offerings each week include 1-2 anthems in addition to psalms, acclamations, and settings of the service music. The choir also provides music for Christmas Eve, Ash Wednesday, Holy Week, and Easter.

In Holy Week of this past year, we once again enhanced the dramatic reading of the Passion Gospel with percussion. The choir sang Maundy Thursday and Good Friday evening services, as well as the most important service of the year, the Easter Vigil. Easter morning saw our celebration graced by musical support of a brass quartet.

As in 2023, we once again marked June 'Teenth with special prayers and music from the rich heritage of African American music and spirituality.

At our last choral service of calendar 2024, Christmas Eve, we were again able to engage outside instrumentalists (strings and oboe) to augment the generous contribution of our volunteer musicians. These players altogether supported the Christmas Eve service, allowing us to program the choruses from Johann Kuhnau's *Christmas Cantata: "A Child Is Born to Us"* (formerly attributed to J.S. Bach as his Cantata 142) and enhance the rest of the program—from carols to instrumental works.

We are forever grateful for a number of parishioner volunteers who joined in our music making, including Jerry Meter (keyboard), Elizabeth Allen (violin), Chris McLean (trumpet), Sarah Gibson (bassoon), Mari O'Neil (flute) and Mike Ebers (bass clarinet) who are always quick to offer their talents when invited.

2024 Digital Ministries Report

Hello again, my friends!

Ever onward and upward! Things tend to move very quickly in the digital space, but thankfully as I rapidly approach my 35th birthday in a couple of weeks I can confidently say I barely know what Tik-Tok is, so we remain largely insulated from any controversy there!

I would love to share with you some of the key accomplishments and metrics that have happened in our use of technology over the last year:

- In September we celebrated the grand opening of the Woodstock Pantry (with a livestreamed ceremony which can be watched on our Facebook page if you missed it), and moved the router in the Sanctuary to the North wall so that our WiFi network can be accessed from there
- We've installed warm lighting above the chancel so the choir can see their music!
- We've improved our ability to collect analytical data on our livestreams:
 - Sunday services average 12 live viewers who watch for at least 1 minute and 8 more who view for at least 1 minute after publication
 - o The total reach of a Sunday service live stream is higher, with an average 228 people seeing the post and 118 watching for some amount of time.
 - o Mid-Week/Holy Day services average 9 live 1-minute viewers with 8 1-minute views after publication
- We offered live streaming services for 2 memorials; Bettie Meeker, and Patricia McIlveen
- We researched and installed secure software that allows authorized users to log in and operate the streaming computer remotely from anywhere in the world, and there's even a mobile app! This means that even when I am a little ill, or at the coast I can pull out my phone and run the stream as if I were at my console. I can even do it from across the room sitting with the choir, though there are some complications with this plan. Even with this software when I'm gone I still need assistants in the meatspace to do things like wake up the computer and turn on the soundboard, but it is a huge leap forward.
- The All Saints Podcast is going strong, and is a great way to listen back to sermons and homilies if folks missed them or want to ponder something again. This year the podcast averaged 21 listeners per week. You can access all of our podcast episodes by directly visiting our RSS feed here; https://media.rss.com/allsaintspdx/feed.xml, going to our public facing podcast webpage here; https://rss.com/podcasts/allsaintspdx/, visiting the podcast section of the All Saints website, or by searching for us on Amazon Music, Spotify, or Apple Podcasts!

We've also tiptoed into the digital advertising space, running 7 Facebook ads from December 28th, 2023 - December 31st 2024. At first this was done to generate a response to our GoFundMe for the Pantry project, and was done without any tangible way to measure direct ROI (which is a bit of a marketing no-no) but considering the success of the Pantry project I would say it all worked out.

Toward the end of the year I set my own goal of using the social media tools at our disposal more effectively in the coming year, and created an impromptu ad soliciting end-of-the-year donations to support the pantry program - and All Saints' outreach projects in general - that ran from December 26-31, and cost about \$40. I figured worst-case scenario I'm out \$40. Oh well. Now, I can't know for sure the exact efficacy of the ad, but I can tell you that over 5,000 people saw it, it was shared by a dozen people who aren't our followers on Facebook, 83 people clicked through to our donation page from the post, and during that time period we received just over \$2,000 with the item "Woodstock Pantry Donation" specified, so I will certainly be looking into more digital marketing efforts in the future.

Some of our future opportunities in the tech space include:

- I still want to essentially set up one of those rolling professor podiums in the parish hall that has everything a visitor needs to set up a presentation computer, imaging device, connection to a ceiling-mounted projector, etc. and can be stored in the closet when not in use
- I'm watching the app development space for design-your-own services that are optimized for tablet orientation

The Major Renovation Committee has been tasked with exploring how the All Saints building and property could be improved to maximize the usefulness and comfort of this space, and how best to phase this work given limited funds and a desire to minimize disruption. In 2024, the committee released a Request for Proposals to architecture firms, and 9 firms responded. The Committee scored, interviewed, and ultimately selected Baysinger to assist with developing

architectural plans based on the priorities identified by the Parish through surveys and other feedback. During the past six months the Committee has worked with Baysinger to develop schematic drawings of improvements identified, determine how best to phase and group the potential improvements, and develop cost estimates. The committee is now working with the architecture firm to finalize these documents so they can be shared with the Parish for feedback.

Annual Meeting of All Saints Episcopal Church, Portland, OR Minutes of 1/28/2024

- 1) The meeting was called to order at 11:50 AM by our rector, the Reverend Andria Skornik. The Reverend Constance Hammond offered an opening prayer.

The rector announced that she had selected the following individuals to comprise the 2024 nominating committee: Kathy Martin, Ardis Weir and the senior and junior wardens who will be selected by the vestry later today.
- 7) The rector's report was presented by Mother Andria as part of her sermon during the 8:00 and 10:15 services earlier today. At today's annual meeting she introduced the members of the newly created "Visioning Team" which she has created. They are Kathy Martin, Lucille Pierce, Alan Murray, Joe Donaldson and Yolanda Reyes-White.
- 8) The Senior Warden's report was presented by Lindsay Strannigan and can be found in the report of the 2024 Annual Meeting.
- 9) The Junior Warden's report was presented by Sonja Miller and can be found in the report of the 2024 Annual Meeting. Sonja also said that *there are positions available on the Building and Grounds committee*.

- 10) Treasurer's report: Due to a printing error, the financial statements for 2023 were omitted from the report of the Annual Meeting of 1/28/2024. The correct documents will be e-mailed to all parishioners and will be available in written form at the church in the near future. Jerry Meter did a brief report of the church's 2023 financial status during today's meeting.
- 11) The 2024 Budget: due to a printing error, the 2024 budget, recently approved by the vestry, was omitted from the report of the Annual Meeting of 1/28/2024. The 2024 budget will be e-mailed to parishioners and will be available in written form at the church in the near future. The report of the Finance Committee can be found on pages 6-7 of the report of the Annual Meeting of 1/28/2024. Maryruth Storer, chairperson of the committee, gave a brief overview of the budget during today's meeting. She also indicated that *there are positions open on the finance committee for interested individuals*.
- 12) Mother Andria recognized Jerry Meter and Steve Dieterich for their recently completed 6 years of service on the All Saints Vestry. (The vestry recently appointed Jerry to continue as the parish treasurer and Steve to continue as the clerk to the vestry.)
- 13) The meeting was adjourned at 12:15 PM. Mother Andria provided a closing blessing.
